1. A rental deposit of \$40. is required to RESERVE the date of your special event. The rental deposit fee will be returned if there is no breakage, damage, or loss. We expect to pick up our games in the same condition they were delivered.
2. Full rental payment and rental agreement must be received at least 3 days prior to the event.
3. If the delivery address is not the customers' residence, the customer agrees (*prior to delivery*) to obtain any and all necessary permits or consents to be able to use our games during the event.
4. Customer agrees to have site ready for delivery/set up in areas free of trash or pet waste.
5. Customer agrees to protect the rented games from weather damage, breakage, improper use, theft, or loss while games are in their possession. If it rains, the customer is expected to move the games to a dry location to protect them from sustaining water damage.
6. If game pieces are missing, or games are stolen or broken, the customer agrees to pay the replacement cost within 10 days.
7. Cancellations with at least 3 days in advance will receive FULL refund (deposit fee & rental payment).
8. Cancellations with less than 3 days in advance will forfeit the \$40. deposit.
9. Same day cancellations (*before delivery*) due to inclement weather will receive a FULL refund (rental payment & deposit fee).
10. Customer agrees to immediately discontinue the use of rented games if they become unsafe at anytime, and will immediately notify "Richmond Hill Fun Game Rentals" of the facts. We will try our best to replace it (if available). "Richmond Hill Fun Game Rentals" shall not be responsible for injury or damage resulting in games that became unsafe during customer's responsibility and supervision.
11. Customer is expected to ensure that our games are visibly clean by the time we pick them up. By clean, we mean no stains due to drinks, food, or deep visible marks. If games are extremely dirty, a cleaning charge of \$20. will be deducted from the deposit.
12. If the customer needs an extension of time with our games, rental charges will be added at a rate of 10% of the total rental agreement (per hour). The extension will be granted if there is no conflict with another event needing such games.
13. At no time can anyone under the age of 21 consume alcoholic beverages while playing our games.
14. Customer assumes ALL responsibility for damage to property, injuries to persons or pets while renting and/or using our games. The customer acknowledges that he/she is solely responsible for assuring that his/her guests are using our games in a safe and civil manner. The customer agrees that any and all bodily injuries sustained, up to and including death, are the responsibility of the customer and their guests. The customer and guests indemnify and hold harmless "Richmond Hill Fun Game Rentals" and all representatives involved from any and all legal action.
